



#2000 First Deposit Match Offer

Promotion Details

- The promotion is valid starting on **6/26/25 at 7:00 PM**
- Players must be 21 or older, have a valid and active FireKeepers iCasino & Sportsbook wagering account, and be geo-located within Michigan to place a wager on igaming.firekeeperscasino.com.
- Players who deposit \$100 or more on their first deposit will qualify for a series of daily promotional awards dependent upon the value of their first deposit (see daily offer breakdown below:). The award for Day 1 is received immediately upon a successful first deposit, but the proceeding promotional awards require further participation.
- Receipt of the promotional award for that day requires players to successfully log into the platform via their account during that promotional day. No further deposits are necessary.
- The promotional days are calculated individually for each player, dependent on the date of their first deposit. Day 1 in the Daily Offer Breakdown below is the date of the players first deposit. Day 2 would be the next calendar day, continuing until Day 5,
 - Example: If a player's first deposit is July 1st, Day 1 of their promotional offer would be July 1st. Promotional day 2 would be on July 2nd, and Day 3 would be July 3rd.

○ \$500+	Day 1 - \$50 in Fire iCredits & \$10 in Free Spins Day 2 - \$75 in Fire iCredits & \$15 in Free Spins Day 3 - \$75 in Fire iCredits & \$25 in Free Spins Day 4 - \$100 in Fire iCredits & \$25 in Free Spins. Day 5 - \$100 in Fire iCredits & \$25 in Free Spins & 50% Return on Loss (Max \$250) (See below for details on calculation of this bonus)

- Return on Loss Bonus: Dependent on the total player loss (*wagers minus wins*) during the first 4 promotional days, players who qualify for this award who login on their promotional day 5 will revive a percentage of their total loss as a Fire iCredit award. This award is in addition to the static \$100 in Fire iCredits the player will receive on day 5. The Fire iCredit award for each player is can be calculated based via the table below:

- If player fails to successfully log into their account on the assigned day of a promotional award, they forfeit that award. Forfeited or canceled promotional awards can only be awarded to players at management discretion.
- For purposes of this promotion, a players' individual promotional day 1 is the date of their first deposit. The remaining promotional days are between 12:00 AM to 11:59 PM.
- This offer may not be used in conjunction with any other offer.
- The maximum casino bonus awarded to any player via this promotion is \$750, although player wins may result in a larger conversion of Fire iCredits to cash.
- Casino & Sports promotions are strictly limited to one per person, email address, identical payment method.
- Fire iCredits can only be used for casino (slot, video poker, and table games) wagering, and cannot be used on sportsbook wagers.
- The games on which the Free Spins awarded via this promotion may change, but the total cash value of free spins will always meet or exceed the value stated via these promotional terms.

Wagering Requirements

- Free spins are awarded to player are not a bonus, it is not withdrawable. Instead, the free rounds must be used to place wagers on the specific game for which the spins were awarded, and are expended.
- At the completion of the Free Spins, any winning from those spins is converted to Fire iCredits (Bonus.)
- This Bonus carries a wagering requirement before becoming eligible for withdrawal, see below.
- Wagering Requirements for Fire iCredits awarded via this promotion and the associated free spins is below:
 - The wagering requirement of **10x** (ten times) the bonus amount must be met to convert the bonus funds or bonus winnings to cash.
 - Therefore, the requirements specified above means that players have to wager 10x (ten times) the amount of the bonus before they can withdraw any bonus funds/winnings, which will be available in their wagering requirement balance.
 - Wagering requirements refer to the amount of money player's stake during the betting process, relative to the amount of the bonus.

- Games will contribute differently to the wagering requirements:
 Slot Games: 100%
 Video Poker: 25%
 Table Games: 10%
 - For example: a \$10 bet on a slot game listed at 100% will count as a \$10 bet towards meeting the wagering requirements. A \$10 bet on a game listed at 50% will count as a \$5 bet towards meeting the wagering requirements.
- Guests have 7 days to meet bonus wagering requirements.
- Players will have 7 days from the awarding of the free spins to complete their free spins, or any remaining spins and associated winnings will be forfeited.
- All winnings made with bets from the bonus wallet will be retained in the bonus wallet until the wagering requirements are completed.
- As bonus funds have no value until converted to cash by meeting the bonus's wager requirements, funds are not withdrawable from any bonus balance. Once a player fulfills the bonus requirements for this bonus, all remaining bonus funds from this bonus will convert to cashable funds.
- If the wagering requirements are not completed within 7 (seven) days, the entire balance (bonus + bonus winnings) will be removed.
- These wagering contribution rates apply to both RNG and Live Dealer games.

Cancellation
